Dear Judge Stanley Boone/US District Judge/whom it may concern,

I want to speak to you in person or receive some type of idea on what you are planning to do to this case. I was concerned that you dismissed the motion to appoint counsel "at this time" even when I provided evidence to the record that I was being tortured/targeted by the United States government.

I reviewed your history. Are you pro-civil rights and human rights and environment or are you pro criminal justice (against the public, thinking we're all criminals) and American agenda? I was concerned by your history as a US Department of Justice prosecutor, and you traveling to other countries to spread American propaganda. It may be you did so in peace, and not for infiltration purposes or for the American world domination strategy. I am concerned about your allegiance to the US Department of Justice, and time perhaps benefiting from covert protection, and time you may have spent protecting American views. The USA government is guilty of heinous crimes even against their own people, and someone as high up as you .. It brings a question to whether or not you might sabotage my case or protect those involved.

I am peaceful, I am just a victim, I ask that if you have intentions on not reconsidering the appointment of counsel (so the attorney can protect my rights and help seek justice), and if you intend to not hold a hearing and will ignore all the evidence I provide, that you step aside and allow a new judge to be assigned. I deserve to get help, I know how you guys operate, you guys wouldn't even demand proof first from the government that I wasn't being hurt. It has happened before.

Trying to be honest here. If you are the kind of judge that instead likes to educate the planet and believes in justice even willing to strike down the government who is normally protected from criminal prosecution after heinous crimes, and if you have an interest in exploring the judicial system corruption I have faced and if you are not prejudiced and are truly neutral (I have a right to a neutral judge), then I would be glad to have you on the case.

Demonstrate you being a neutral judge without prejudice by appointing counsel and having a hearing first so all the facts can be laid out. I know many judges will claim there is no civil rights violation simply because they personally are prejudiced, and refuse to acknowledge the possibility that any of this is real or true, despite evidence being entered on the record showing otherwise without a valid contradiction, and despite not even demanding any evidence that shows it isn't happening.. The electronic assaults, surveillance, and military abuses I have faced..

Enclosed are several new exhibits. I included the full bioethics committee transcripts with dozens of victims giving public comment about their own torture and abuse. The bioethics committee referred the information to President Barack Obama in 2011. In fact this is a Presidential Committee original established by President Bill Clinton to prevent heinous atrocities like this from ever happening again as it had been exposed for doing many times in the past, including during the time the President established the Advisory Committee for Human Radiation Experiments after investigating the previous acts to torture citizens with radiation and mind control. But an included letter from the bioethics

committee actually says they are not going to help any of the victims which is truly criminal. No one has helped any of the victims yet to date, leaving innocent people to die, commit suicide, and live with torture they shouldn't have to. My case is as much about my own targeting, as it is everyone else's. Without me, no one will get help any time soon and many years have lapsed till this point, this is also why a judge must hear my case, otherwise you're signing off on everyone's torture and abuse and preventing this from being taken care of.

Several other new exhibits also included..

Here is the strategy for my Habeas Corpus because I am sure you have never seen one like mine. The deal is, government cannot initiate a program of imprisonment or custody without due process on American soil; The government has built a system of drones, ie satellites and radar that can control the population remotely. They can kill ie initiate an execution remotely, they can target and imprison people using electronic weapons means, seizing their body, torturing them, and destroying them all in total secrecy. The satellites and radar systems have automated targeting and can work from very long range, and do not need to fly over a person to work (some bounce radiation to the sky down into people from hundreds of miles distance). This is of great concern, that the government could kill or torture someone without due process as such, no different than if the President started to fly drones over the entire country, and whenever they wanted they could pick an individual off without any court oversight using a missile; except the satellites and radar use radio frequencies, microwaves, terahertz, scalar waves, radiations, particles, and invisible things hard to detect. Unless you guys have secretly allowed it somehow, but it's possible this is done under one of several Presidential Executive orders or Special Access Programs to which the President and government agents do not need to seek court review or approval. 12333 is one, 13526 is another.. The USA military does not need to obtain court approval to spy on citizens using these means and can attack people using the same systems, through these two Executive Orders, bypassing the FISA court, bypassing the courts all together (in fact there are articles on the internet about it this month, see Ars Technica online). In a murder or crime they don't need permission, either, they just have to keep it secret from everyone else..

The government has built a world scale torture prison with their satellite and military radar.. They could seize control of you as well, or kill you, before anyone could stop them.. Population control and imprisonment is in full force, and the spider cannot be stopped before preying, and it's a very strong and vicious spider indeed. I want freedom, that is the point of my Habeas Corpus, freedom from government watch and target lists, orders to force them to release me from this covert prison, and I want protective orders to prevent my death and torture further. The information I have to share about these atrocities is too important to overlook, it must be taken care of...
