From 2006-onward, the US DoJ investigated Oregon State Hospital (OSH) due to Oregon's continuous abuse and exploitation of its' mentally ill population. Rather than provide opportunity to live and grow, people were being warehoused and deprived in what amounted to more of a dilapidated concentration camp and slaughterhouse than a hospital, which was largely due to the needs of state workers who through their unique position dictated the function of the mental health system throughout Oregon. The system is designed to funnel millions to state employees who work at Oregon's primary care facility for the mentally ill. They leech off the population of mentally ill, leaving little money for community based support or programs. The hospitals function always seemed to be about holding onto people, and rather than money going to enrich a persons life, it goes directly to fund fat, overpaid, greedy, and thoroughly entrenched state workers who get paid 2-3 times what employees in other mental health positions in the community receive. They enjoy generous benefits and do doubles nearly daily by choice, earning time and a half every double, making upwards of \$80,000 yearly with no college or professional education.

This was their motivation when state employees lobbied hard for a new hospital that others felt shouldn't have been built. The thought of others was little could be done to treat people in large prison like facilities, and that it was detrimental. The facility emulates a hamster cage very well; there are the tubes (halls), where patients spend their days forced around to hamster wheel after hamster wheel (repetitive unstimulating groups which do little but replicate what people are already doing on their own, short of anything close to what they will be doing when they leave). Everyone is also forced to engage in mutilative medical treatments (medications) whether it helps them or not, and most leave the facility crippled. As a result, they go nowhere, get nothing, and improve little, and most people only seem to degenerate when they're here. This system is obviously detrimental, and the original plan called to build smaller community centers, which were seen as innovative, and a way to modernize the system. Instead state workers went to town at meetings about the plans, to instead have a system built more to support their own needs, complete with a new hospital right here in Salem, same as the old.

At the hospital, there is also a slaughterhouse component, and that includes the abuse and unlawful use of forced treatment with hazardous substances – the constitution is meant to protect everyone from assault and experimentation, but apparently it doesn't apply to OSH quite yet. The process to allow exception to the constitutions protections needs to be abolished and a challenge in the courts ought to suffice.

People only go through this because they are here, and people here are actually stuck in limbo; few are convicted of crime, yet they are held in this prison like facility, often indefinitely without due process to get out. It's a type of Guantanamo Bay here on American soil for any citizen who happens to get shipped there. The constitution does say

this is illegal, yet staff needs are apparently more important. This place only exists to give staff a place to work, and that's how everyone is treated.

There were many opponents to building the hospital, but the union was in control. Bob Nikkel (DHS Administrator) made attempts to loosen the unions grip, which upset union members. He attempted to include patients in the meeting process, for example to drown the loud and dominating voice of opportunistic union members, which resulted in angry personal attacks behind closed doors. Randy Davis had a full conversation about Bob Nikkel on 48C in 2007/2008. "Bob knows what he's doing, he's trying to censor us and make it so we can't talk". "we can't talk with patients involved". Union reps saw it as their time to get what they wanted and this meant using their one sided views on people and mental illness to increase their relevants and importants, even if it were detrimental to others, or a waste of tax payers money. Another opponent was Salem's own mayor. When she spoke out, union representatives were quick to engage in public personal attacks through the media to dismiss her as a quack. You immediately questioned her sanity when you read their response. This is basically what occurred in any situation about the hospital, it was a game of emotional manipulation with a bunch of union dogs clawing at their way to both appear as sensible and respectable, and at the same time make everyone else out to look crazy.

The hospital staff tend to portray themselves as the poor helpless victims or good honest and caring people, working in terrible conditions and always denying responsibility. They degrade and dismiss the people they care for, force and bully them around, and promote them as violent and incapable. Most could be functioning independently or on their own in a supported group home. Except staff promote the illusion that there's a need for this, people need this place, and staff are relevant.

Then there was OSH2. Same staff, same abuse, new building, complete with new methods to control and abuse patients with. And they intend to further build on this platform in Junction City, blocking attempts to modernize or improve the system.

While all this was going on, the US DoJ issued a report in 2008 detailing grave abuse and civil rights violations at the hospital, stopping short of suing the state or shutting the facility down. What was not told is the US DoJ had uncovered and was aware of unlawful experimentation, torture, and crimes being committed by staff in the facility. The US DoJ also participated in the behavior and collaborated to hide the abuse, including the secret use of psychotronics and synthetic telepathy at the facility. Instead of coming in to shut the facility down, or to expose abuse, they came in to enrich and stabilize security at the facility, and possibly to oversee experimentation and abuse that was occurring. The hospital enjoyed special protection due to willingness to harbor such secret programs, and its relationship with many powerful federal and state agencies.

I'd like to give a sarcastic thanks to David Deutch, and Robert Koch, two in charge of the hospitals investigation at the US DoJ. I called both in October 2012, and they both seemed to know me and be aware of the situation (I recall how DeAnn Major of DRO told me in 2008 that she was going to help build my case against OSH for the US DoJ, who was apparently using the technology to spy at the hospital, basically using me as a science experiment (she was acting as an informant and vessel to engage in conversation for them from outside of the building)).

David and Robert acted like I was trying to expose something they were close to, and refused to help. It was sort of like they were surprised I went to them, and they spoke cryptically and like it wasn't something they were allowed to talk about. "it would be serious if it were true," yes it would be, David..

I told David Deutch that I couldn't help him with his indiscretion, that I wasn't interested in a cover up, and the psychotronic US DoJ penis needed castration. The type of abuse facilitated by psychotronics, and synthetic telepathy went against everything they were supposed to protect and fight for. They were both fully aware of its' existence, and what people did to torture me.

I recall the dudes gang stalking me on the streets, two undercover agents from July 2012. They whistled at me (something OSH staff started) as they walked by to get my attention, and then walked to the end of the hall. One turns his head over his shoulder, and states like he knows the future, "you know what's coming, right?" Soon after, the Eugene Police falsely arrested me, and my computer and cellphone were stolen. I was being set up again. I was taken to Lane County Jail where it was easier to rape and control me, and they could hurt and target me easier with this technology. Before this, I had plans in the works to hire my own doctor, and they wanted to interfere with this, the health care I was trying to get, and the work I was doing to build my case, including developing my website. They were watching and controlling me the whole time with this technology.

I am raped several hundred more times in Lane County Jail, nearly die, and am returned to OSH for them to further sabotage me and my case and to bury me in lies and abuse. You can't escape a system that is corrupt head to toe, and covers an entire state or government.

I will also post this all to my site in hopes of world exposure, hope that I get help before I die.

Two police officers who were set on taking me in March 13<sup>th</sup>, 2011, part of the people gang stalking me, Grice and Bezates of the Springfield Police Department, beat me senselessly in front of my own family. I believe this is the case to expose gross misuse of the governments most highly kept secrets. Directed Energy Weapons and Mind Control, secret spying and human sabotage, all here in Oregon. I also want to fix Oregon's legal and mental health system, and protect others from going through what I and what I've seen many others endure.

It makes me very sad to realize how evil our government really is. Where's the integrity, the gold standard and zero tolerance for abuse or corruption, the government that's friendly and transparent, and realizes no need to hurt another or lie or keep secrets, no matter what? This needs to be the standard.

I'd like to see a civilian board set up to oversee military, police, and government conduct and operations, technology and money spent, to make sure it's justified and in the peoples interest. My problem is trying to figure out how for 20-50 years after psychotronics became a threat, the government still covets this technology in secret, still abuses it and gets away with gross crimes against the unlucky people they target. This is completely unacceptable to me. My belief is it is time that these agents and government entities open up and start behaving, just the same as citizens are expected to. They need to realize their only purpose is to protect everyone else, and their duty is to us, the citizens, not themselves. They are no better than us, and aren't above the law. We are one and their technology belongs to us, and we all deserve to have access to information and about how they operate and watch us, so that we may monitor it, approve it, and contest it. That means technological development, capabilities, and deployments are public knowledge and information, not classified secrets, and it's all spelled out in public view their mission statement, their duty, and methods of operation. They may not stay from their duty to us, the people. They need to be retrained to respect personal liberty, and freedom, and to respect boundaries. This means realizing limits of agents and governments, and protections for individuals and citizens once again. Things like privacy, and limits on force and detention are important, access to impede an individual's freedom
