and covered most of the crimes of the state/staff up. My release was sabotaged. They used
illegal surveillance at OSH during the US DOJ CRIPA investigation that began in Oct 2006.
The state covered this up by using military directed energy weapon on me in Aug 2008;
There is hospital security footage backing me up, staff discussing tech outside of building.

Why did you become a suspect? I had been under illegal surveillance by state; dealing with harassment, stalking, and illegal assaults by the police. The operation was ongoing in Lane County/Springfield including misconduct by police and state starting March 2010. Numerous abusive events including military operations against me occurred, using interferometers and directed energy. The police were spying on everything I did, in my home, w/o bugs, using microwave interferometry. They are able to direct energy to assault me in my home.

Why do you believe you were arrested, if not for actual commission of the crime? _____

The police came out after my grandfather went to police. I complained my grandfather was involved in the operation, keeping my abuse a secret. It turns out the abuse I was going through was real, per my latest psychologist eval. It's backed up by news paper articles, and whistleblowers from within government. The police came out and brutally assaulted me, and then arrested me. For claiming they "knew what they were doing" . They picked the door to my room and entered illegally.

I believe my grandfather gave them permission because he was getting protection from them, participating in what they the CIA and state did to me. I was arrested to cover up the police assault, they claimed I resisted arrest when I didn't.

I overheard the police discussing with an FBI agent Roberts over a covert brain-to-computer interface what had happened, he was apparently upset. But still due to the circumstances of the assaults I would not get help during the case.

In an affidavit and recording, Clyde admits he self inflicted wound and started a fight with me, then went to the cops. I was the one arrested after the cops came out, using this as a reason to harass me as they had done previously. They knew what was happening in the house prior to getting there due to illegal satellite/military radar surveillance, per my website. They call the method of surveillance interferometry and NSA Electronic Brain Link.

My appeal attorney has not done anything on the case so far I am just saying this is the reason I have asked to overturn the case or to seek a decision by the court to overturn the plea agreement.

Appeal is still ongoing. My attorney is the type to believe that there is no mechanism for appeal and I should take this up under post conviction relief. I would not know any better and believe he has denied me effective counsel, wasting my time for 2 years. It is true he has not spent any time or energy defending me or investigating what really happened outside of the court transcripts which talk about this issue but apparently cannot be brought up on appeal according to him.


