Doctors in the ER and Psychiatrist Dr. Misty Richards and others denied medical tests to verify my ~~to~~ brain and nerve muscular injuries.

Dr. Richards violated informed consent laws, and ordered medications without asking me if I wanted them, without telling me their total purpose, or side effects. I refused them on the basis that she also misdiagnosed me with psychotic disorder.

I frequently asked ER staff for proper medical care and they refused.

I waited 3 days till Monday ~~the~~ 4/4/2014, and then I was admitted to Resnick.

For two more days they refused to give medical care and offered me medications I didn't need including Abilify and Risperidol.

I noticed staff frequently watching me far away and continuing to refuse help. It all seemed ~~very~~ staged, like I was being talked about and watched ~~the~~ 4/6/2014 with no incident. Doctors threatened to force risperidol and to hold

me at Pennick against my will.

They also looked at and deliberately ignored all my past technology and medical records about my condition that contradicted their behavior and diagnosis. This is deliberate indifference <sup>of my</sup> needs.

I was upset and threatened to sue for the abuse.

When CCHR had an attorney call me, ~~Pennick~~ and when I informed the Social Worker that my counselor and CCWS Ron Unger by phone agreed with me that I was being falsely held, because I was not gravely disabled,

Pennick ordered a transfer to a new facility, perhaps onto their refusal to treat or help me, claiming my insurance was not accepted at UCLA. I do believe UCLA does take Medi-Cal and all other insurance and feel this is a sign of discrimination and their abuse of me/refusal to treat
