Hi I did not get a call till after this email came, it is March 4th 2016 at 7:50pm now. I didn't expect him to call since you said he already called but when I check the logs on Google Voice no such call is logged. I just listened to the message. It came 2 hours ago. 2 hours ago was at 5:50pm. This email came at 2:10pm claiming he missed calling me yesterday and had called me this morning. I have that electronically recorded.

In the message he said "when we get that release of information back we will request your records." I sent the release of information back to Craig already and it was received by email earlier this week March 1st 2016. That was three days ago.

From me there has only be 1 phone call and 1 phone call from my psychologist who said he was calling you last night.

Emails are not counted as numerous emails.

You have failed to answer the question on if there is a conflict of interest with your firm representing me. That is the most pressing issue next to my physical safety from torture and surveillance by the state.

Hi I already have a private investigator named Jennifer Maghinay on this case and she wants rehired. She intends to help prove all the aspects of my abuse. We are starting off the investigation with crimes that happened against me at the Oregon State Hospital including surveillance abuses, murder attempts, sexual abuse, due process violations,

mind control, torture, Bonita Tucker scandal - and security video and audio existed of my abuse giving us the upper hand and presumption of guilt under the law unless they demonstrate their innocence. These scandals explain how the state, police and DA targeted me in the community and why they assaulted and came after me - all of these issues violate my rights during/before the trial and prove my side that I was factually innocent and set up.

I also have a list of 50 government scientists, investigators, psychiatrists, whistleblowers and others I want brought in.

Still waiting to hear back on the conflict of interest and other material. That is the most pressing issue. We need to have dialogue on what is going on in this case and on all issues that get raised to proceed. Then we need to find out how we are going to protect me and move to expose the state for these acts.
