## Tort claim notice

Hi. I have been a resident of Modesto since March/April 2014. Upon arriving to Modesto, the Modesto police entered into a conspiracy against me, allowing the federal government to abuse me, participating in illegal surveillance, and allowing me to be assaulted with a directed energy weapon and stalked on the streets. The local hospital DMC participated and did some businesses. I have repeatedly tried to get help, telling the police about these abuses. The police had been to my grandmas house, Sharon Mackey 3921 Weston Way, Modesto CA 95356 repeatedly responding to domestic violence claims invoking the other residents Stacy Giffen and Jason Searles. Jason has repeatedly injured Stacy and Stacy repeatedly injured Jason during spring and summer long incidents, the cops would deny us assistance even when weapons and injuries and drugs were present. The drugs included meth and marijuana. In addition I passed info about my abuse, almost immediately. I offered the cops a DVD of evidence and told them my website, which is backed by my psychologist, and USIS, DOD, CIA, FBI whistleblowers Amanda, Dr. Robert Duncan, and Ted Gunderson. The cops refused to take the DVDs. Over summer I went into the police station directly with printed affidavit, psych evals, DVDs, and info. The police officer refused to take the information and refused to allow me to file a police report. I demanded he make a recording of this complaint and investigate it. He refused or at most said he would make an incident report only.

I recorded these incidents via microphone recording.

October 3rd 2014 .. The cops came to my house and falsely arrested me. They had orchestrated this arrested because I was being illegally spied on and all information about my plans passed to the police. The military surveillance system allows them to image and record me in my home, as a form of building penetrating tomography/space capability. The officer tried to claim I was a danger to myself or others and that complaints had been made. I provided him psych evals and my website that said I was in fact a victim, and that I was not a danger to myself or others. I partly recorded this. The officer still took me into custody and was abusive. I had him read the report from his computer and indeed a report was made, but all it said was that I had reported being a victim of military assault and violence in my medical records to my doctor. The records , one record, from a DOD, CIA, FBI, physicist / whistleblower, Dr. Robert Duncan does back me up that I am being targeted and tortured by ruthless people and software. The police are heavily involved, and protecting it, and have full access to the system.

It does not have any info about me making any threats or otherwise as the officer tried to claim, which would have been required for the arrest. He took me to DMC where I was abused by staff, who were in on it. They whistled at me and smeared and were rude, and they denied me release and medical care. I was falsely confined for 24 hours after transfer to another hospital site run by DMC and another ran by Stanislaus County in Ceres, where I was abused and violated. I was finally released, and I filed complaint with my insurance and they determined the stay to be unnecessary.

The officer I got on video telling me he would investigate the crime documented on my website, [obamasweapon.com](http://obamasweapon.com) which is occurring in Modesto now. But he did not.

I had been planning a move to a new city thanks to constant violence and abuse, and to seek medical care and work with my lawyers in Oregon.

On January 18th or 19th 2015 I was assaulted, threatened, and hurt by my mother the meth addict. She is the only one in the house who has continued to be violent even since her husband Jason was kicked out and arrested. We know Stacy has used meth 8 times since just November and gets meth from her cousin Melvin. This helps keep her amped up, and violent. She has attacked me, my brother Sheldon, my grandma Sharon, and my aunt Kris. As evidence of non stop violence, we get yelled at routinely, she has



broken iPhone after iPhone, she has wrecked recklessly hit other cars and almost caused accidents including backing into my aunts car in a rage fueled fight. She cusses us out. She hit my grandma .. She pushed my aunt Kris around. Before I got here this was going on too, as all my grandmas care givers including Julia (live in care taker) was exposed to violence once my mom and Jason got here, all 5 care givers left. As evidence there were signed letters from Julia left on the previous home PC, indicating that due to violence and physical assault and threats, Julia had permission to leave under her contract when Jason and Stacy were present. She left Feb 2014. Back to Jan 18th and 19th 2015, the cops were summoned and both refused to act even after Stacy admitted that she had been using meth and finally after I played a recording to the officers of her saying she had used 8 times (recently). Its of my opinion that this meth use and other mental issues causes her to be violent, amp'd, and unable to calm which leads to this non stop violence and fighting and threats to everyone. I also informed the officers of the name of her own family member who she claims has given the meth. I believed meth use and possession was illegal and the whole family is in agreement that she needs treatment. Friends of Stacy' have also came to me in concern which knew of her past drug history and suicidal tendencies. The cops left and told me to just go into my room or leave. I continued to record them. They left and before I could get to my room, Stacy started yelling and arguing and gesturing to attack me again. I went outside and said she is starting it right back up and will not leave me alone. I played recording for cops. Cops also act angry and tell me rudely to shut up/listen. I said look I know the law and my rights. This is domestic violence per the penal code. They say no it is not, unless I was her husband. The cops have a history in Modesto of ridiculing citizens and refusing to make arrests when violence is occurring. Plus I believe they know who I am, and all refusing to protect me specifically. They misquoted the law because I was able to easily pull up the codes that list cohabitants, mother and son, and other relationships, and threats, physical assault and many types of violence as reasons yo make mandatory arrests. Previously the cops also refused to make arrests when Jason was carrying knives around the house, threatening us, and carrying drivers to use as a weapon, while threatening us. Jason even fist fought a neighbor in the streets .. The cops said none of this was a crime. I wanted to finish my medical care and do my legal stuff here, but am now moving. I believe the cops violated my civil rights and have put me in danger and are responsible for lying to me about the law repeatedly.

Additionally, I have been severely beaten by a military weapon and hold this city and actors fully responsible for damages, and wish for a criminal investigation, including all audio and video and reports to be saved from the officers video and audio recorders (T y wear video and audio recorders, today they told me I could make a request to have the footage saved. I wanted the footage saved and provided of all occurrences of the police or spending to my house since March 2014).

Any saved footage will be used to prove the police were prejudiced against me, abusive, failed to protect me, participated in assaults, murder attempts, participated in illegal surveillance, lied about incidents and the law, failed to enforce the law, etc.

I also notified chief of police and mayor and city counsel my emails before and they failed to act. I also made calls to the internal affairs office about abuse and they failed to call back or investigate.

Another potential violation is deliberate indifference but I believe I have been targeted deliberately.

Information on my brain injury including chronic traumatic encephalopathy and psych evals and more, and my own attorneys brief in court as evidence of my abuse and targeting is on my website.

The military weapon involves the use of directed energy to assault my body, damage my soft tissue, rape, torture, etc. Dr. Robert Duncan explains it as signals impingment of my body with radar frequencies or signals intelligence.

Requesting \$200 million to resolve the complaint from the city of Modesto.
